1.	The total number of sections of the school shall be restricted to 18 as per the number of sections reported during inspection, of which not more than 1/3 <sup>rd</sup> sections may be used for senior secondary classes and further increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law subject to availability of class rooms greater than 500 ft dimension.
